PROVISIONAL SELECT LIST

1. In pursuance to the Notification dated: 18.1.2016 cited at reference, recruitment process to fill up 08 posts of Sub-Inspector (IRB) including in-service was initiated. The Endurance Test and Physical Standard Test to all the candidates who had applied for selection to the above said post was conducted and further written examination was conducted on 26.6.2016 to all the candidates who had qualified in the Endurance Test and Physical Standard Test. After conducting the written examination, candidates were called for Viva-voce from 22.8.2016.

2. Whereas, as per the procedures laid down in the Cadre and Recruitment Rules called "The Karnataka State Reserve Police (Recruitment and Conditions of Service) Rules, 2009", based on the total marks secured in the written examination and Viva-Voce, a provisional select list in the

order of merit of candidates equal to the number of vacancies notified should be published.

3. Whereas, during the process of selection two candidates namely Sriyuth Anil Kumar. G. and Praveen M.D. in their representation cited at reference 4 & 5 have submitted a declaration stating that they have already been selected for the post of Police Sub-Inspector (Wireless). Further they have also stated in their representation that in case if they get selected to the post of Sub-Inspector (IRB), they are not willing to join the said post rather they would like to join Police Sub-Inspector (Wireless). Apart from this, two candidates namely Sriyuth Dayanand & Vijay Kumar in their representation cited at reference 2 & 3 have stated that they were called for viva-voce even for the post of Special Reserve Sub-Inspector of Police (KSRP). They have stated in their representation that, if they get selected for the post of Special Reserve Sub-Inspector of Police (KSRP), they would like to join for the said post. Accordingly, the requests of the above candidates have been considered and in their place, the candidature of next eligible candidates has been considered for selection. The provisional select list is prepared and is as follows:


- a) This list is subject to the outcome of the results in the medical examination to be held by a Medical Board constituted as per the rules.
