As per the conditions stipulated in the Cadre and Recruitment Rules called "the Karnataka State Reserve Police (Recruitment and Conditions of Services) Rules, 2009", the candidates included in the Provisional Select List were subjected to a comprehensive medical examination before Medical Board.


2. Whereas, after the conduct of medical examination to the candidate selected, the Medical Board vide letter No: B&LCH/PS/175/2016-17, dated: 3.10.2016 has sent the report furnishing that all the candidates who were subjected for medical examination are 'FIT'.

Whereas, as prescribed in the Cadre and Recruitment (Amendment) Rules called "the Karnataka State Reserve Police (Recruitment and Conditions of Services) Rules, 2009", after medical examination the Selection Authority has to prepare Final Select List on the basis of report sent by the Medical Board. The following is the Final Select List of the candidates in order of merit selected for the posts of Sub-Inspector (IRB) (Men) including In-service.

- a) This list is subject to the verification of relevant documents like Proof of Age, Educational Qualification, Selection Category/ Group, Community/Caste, Rural, Kannada Medium, Project Displaced Person, Discharge Certificate in case of Ex-servicemen, Hyderabad-Karnataka Reservation etc., issued by the competent Authorities and verification of Character & Antecedents of the candidates.
- b) The final appointment is subject to verification of Annual Performance Report and Departmental Enquiries if any pending against any of the In-service candidates.
- c) The fact that the name of the candidates figures in this list does not give him / her any legal right for appointment to the post which will be dependent on the aforesaid conditions.
- d) The Select List is subject to the final decision of the Hon'ble Karnataka Administrative Tribunal/Hon'ble Courts, if any.
